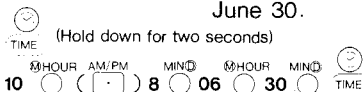

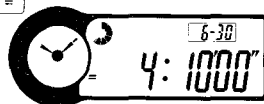
■ CLOCK

- The current time → To set the clock to 10:08 AM, June 30.



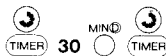
■ TIME CALCULATIONS

- To perform the calculation 3:40 + 30 minutes.



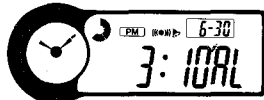
■ TIMER
